2021 Board of Directors Nomination Process

The nomination of 2021 South Bend Area REALTORS® Directors is an open process in which Association members may apply themselves (self-nominate) or nominate fellow members. Candidates must be a current REALTOR® member of the South Bend Area REALTORS® to be considered and meet the eligibility requirements.

When completing this form, please be aware that three industry references are required.

Nominations/Applications must be submitted by August 10, 2020.

Nomination forms can also be printed and, once completed, should be mailed to: **South Bend Area REALTORS® 1357 Northside Blvd, South Bend, IN 46615**, but must be received by the August 10th deadline.

The South Bend Area REALTORS® nominating committee will review nominees to ensure they meet the qualifications of the position and may request an in-person interview of applicants.

The SBAR nominating committee will provide a recommended slate of candidates to fill vacant seats of Officers and Directors for the Association for 2021, these candidates will be presented to the Board of Directors for approval at the Board of Director's meeting via email after which time the slate will be presented to the membership. Members will be notified a minimum of 30 days prior to the beginning of the election which is conducted via electronic ballot during October in accordance with the Association's Bylaws.
